TYPE OF PRODUCTS AT YOUR BOOTH:

General Vendor Information:

Booth space is \$150 for a 10x10 space in the Taylor Telecom Arena Concourse or the First Financial Pavilion Livestock Barn at the Taylor Co. Expo Center. Payment must be received by October 1. Payments are non refundable. Vendor is responsible for collecting and paying any applicable sales tax.

Move-In begins on Tuesday, October 26 at 3pm. Booths are encouraged to be set up by 4pm on Wednesday, October 27. Competition begins at 6pm Wednesday, October 27. No move in will be allowed in the Pavilion after Wednesday due to competition in the nearby arena. Booths must be set up and open by 10am on Thursday, October 28. Booths will not be allowed to dismantle until the conclusion of the show on Sunday due to the proximity of the competition arenas. Trailer or large equipment move in must be coordinated with show officials. Please call the office at 844-846-7468 to make arrangements.

Booths should be open Thursday, October 28 through Sunday, October 31, at 10am until the conclusion of the show.

There will be three evening special events in the Taylor Telecom Arena: 1) Welcome Party on Wednesday at approx. 6pm; 2) Fence Work Showcase on Friday evening at approximately 6pm, and 3) Freestyle Reining & Exhibitor Awards Party on Saturday at approximately 5:30pm. That is when awards will be handed out.

Vendor space is 10x10. Electrical (110) drops are available along the wall in the Taylor Telecom Arena and overhead in the Livestock Barn. A table and 2 chairs available on request. (please give us one week notice). Vendor spaces are in an open area alongside the arena. Please, no visually or audibly distracting booths since horses will be showing nearby.

Due to the arena side location, the Livestock Barn can not be locked overnight. SHTX has hired a security guard to walk through the barns overnight on Thursday, Friday and Saturday nights, however SHTX assumes no liability for security of your booth and contents. The Taylor Telecom Arena concourse is climate controlled, the Livestock Barn is not.

Additional terms and conditions:

The Vendor assumes sole responsibility and hereby agrees to protect, indemnify, defend and hold harmless the Association, the Taylor Co. Expo Center, and its employees and agents, from any and all claims, including claims or causes of action arising from the sole negligence of said indemnities, arising (a) out of, or in connection with Vendors occupancy and use of the Trade Show premises, or any action or inaction of any nature in connection with or related to the Trade Show, including but not limited to loss, theft, damage, destruction, or delay in no delivery of goods, display material and other effects; (b) any injury to Vendor, Vendor's employees, agents, representatives or guests while on the Trade Show premises; and (c) any damage to Vendor's business by reason of failure to provide space for the exhibit or removal of exhibit or failure to hold the Trade Show as scheduled. Vendor acknowledges that the Association and Taylor Co. Expo Center do not maintain insurance covering Vendor's property and that Vendor has the sole responsibility to obtain business interruption and property damage or theft insurance covering such losses by Vendor. Vendor agrees to indemnify and hold forever harmless the Association and Taylor Co. Expo Center, from any and all damages, loss, liability, claim or expenses (including legal fees) based upon, arising out of, or in connection with the violations of any law or ordinance by the Vendor, its employees, agents, representatives, guests or other holding under the Vendor; or if failure by Vendor or any such persons to comply with all applicable terms and conditions contained in these rules or in the agreement between the Taylor Co. Expo Center, and the Association regarding the Trade Show premises or a part thereof. If the Indemnities are sued in a court of law, Vendor agrees to defend the Indemnities at Vendor's expense, and if judgment be taken against Indemnities, to pay said judgment and obtain written release in form acceptable to the Indemnities.

Sponsors will be given priority assignments. Vendors must be approved with preference given to those with items applicable to the stock horse industry. First come, first serve priority will be given to vendors according to the time their contract is received.

Vendors are responsible for any damage to Expo center property.

Any advertising materials may only be distributed through the vendor's booth. Any soliciting outside of the vendor's booth is not allowed.
